**NOTIFICATION**

No. 15/2(4)-2/2017-A-I Mr. Muhammad Yusuf, a BS-20 officer of Mechanical Engineering Department, was served with a Charge Sheet of even number dated 13.04.2018 by the Secretary/Chairman Railways (Authorized Officer) under the Government Servants (E & D) Rules 1973, for gross misconduct & inefficiency in connection with irregularities in procurement of thirty (30) Diesel Generating (DG) Sets during his posting as Deputy Chief Mechanical Engineer and Managing Director, Pakistan Railways Carriage Factory, Islamabad. Mr. Aijaz Ahmad Buriro, the then Additional General Manager/Mechanical, Pakistan Railways, Headquarters Office, Lahore, was appointed as Inquiry Officer. On receipt of Inquiry Report he was served with Show Cause Notice of even number dated 06.03.2019 by the Secretary/Chairman Railways (Authorized Officer). The Authorized Officer also granted an opportunity of personal hearing to the accused officer on 24.07.2019. The case was referred to Prime Minister of Pakistan through Establishment Division vide this Ministry's Summary for the Prime Minister of even number dated 06.11.2019 by the Secretary/Chairman Railways (Authorized Officer) with the recommendations to impose upon him a major penalty of "Reduction to Lower Post".

2. The Prime Minister of Pakistan (Authority), after consideration of the above position and recommendations of authorized officer, has imposed a major penalty of "**Reduction to lower post for one year**" upon **Mr. Muhammad Yusuf**, under rule 5(1) (iv) of Government Servants (Efficiency & Discipline) Rules, 1973 with immediate effect. The Prime Minister of Pakistan has also approved that on **restoration, future increments shall not be postponed**.

3. **Mr. Muhammad Yusuf** has a right to prefer an appeal to the President of Pakistan (appellate authority) against the above penalty within 30 days (Thirty Days) after the issuance of this order.
