**NOTIFICATION**

No. 15/12-1/2020-A-I. Mr. Muhammad Irfan Akbar, a BS-18 officer of Civil Engineering Department of Pakistan Railways, while working as Divisional Executive Engineer, Pakistan Railways Peshawar was served with a charge sheet dated 03-10-2020 under Government Servants (Efficiency & Discipline) Rules, 1973 for gross misconduct and inefficiency in connection with illegal renting out godowns at Mardan. Initially Inquiry Committee comprising of Ms. Maryam Gilani, the then COPs/Safety, PR, HQs Office, Lahore and Mr. Irfan ul Haq, the then MD/Stations, Pakistan Railways, HQs Office, Lahore were nominated. After proceeding of Ms. Maryam Gilani on leave, Inquiry Committee was re-constituted with Mr. Irfan ul Haq, the then MD/Stations, PR, HQs Office, Lahore and Mr. Muhammad Farooq Iqbal Malik, the then CCM, PR, HQs Office, Lahore as its members. On the basis of Inquiry Report, Show Cause Notice was issued to the accused officer on 09-03-2021. To defend himself, the accused officer was also granted opportunities of personal hearings by the CEO/Sr. General Manager (**Authorized Officer**) and Secretary/Chairman Railways (**Authority**).

2. After consideration of the available record, examining the Inquiry Report as well as personal hearing, the Secretary/Chairman Railways (**Authority**) is pleased to impose a Major Penalty of "**Compulsory Retirement**" upon Mr. Muhammad Irfan Akbar, in terms of Rule 5(1)(iv) read with Rule 4(1)(b)(ii) of Government Servants (Efficiency and Discipline) Rules, 1973 **with immediate effect**.

3. Mr. Muhammad Irfan Akbar within thirty (30) days from the communication of this order can prefer an appeal to the Prime Minister (Appellate Authority) against the above penalty.
