**NOTIFICATION**

No. 15/1-Med/2017-A-II. Dr. Muhammad Arsalan Khan, (BS-17), while working as Medical Officer, Pakistan Railways, Quetta, was served with a charge sheet under Government Servants (Efficiency & Discipline) Rules, 1973 for gross misconduct and negligence in connection with unauthorized absence from duty with effect from 26-01-2014. Dr. Muhammad Aslam Sandeelo, Dy. CMO, Pakistan Railways, Headquarters Office, Lahore was appointed as Inquiry Officer. On the basis of enquiry report, show cause notice was issued to Dr. Muhammad Arsalan Khan. Since no reply was received to the Show Cause Notice, therefore, a notice was published in the Daily Newspapers on 22-01-2016 but no response was received from the accused officer within stipulated period.

2. After consideration of the above position and recommendations of the inquiry officer as well as authorized officer, the competent authority (Secretary/Chairperson Railways) has been pleased to impose a Major Penalty of "**Removal from Service**" upon Dr. Muhammad Arsalan Khan, in terms of Rule 5 (iv) of Government Servants (Efficiency and Discipline) Rules, 1973 with immediate effect.

3. Dr. Muhammad Arsalan Khan within thirty (30) days from the communication of this order can prefer an appeal to the Prime Minister (appellate authority) against the above penalty.
