NOTIFICATION

No. 15/5-1/2016-A-I. Mr. Mubashar Hassan Malik, Ex. Dy. Chief Engineer/Middle, Pakistan Railways, Headquarters Office, Lahore a BS-18 officer of Civil Engineering Department of Pakistan Railways, was served with a Charge Sheet by the Chief Executive Officer/Senior General Manager, (Authorized officer) on 04.03.2016 under the Government Servants (E & D) Rules 1973, for gross misconduct due to un-authorized absence from duty w.e.f 28.12.2015. Mr. Zafarullah Kalwar Ex. Divisional Superintendent, Pakistan Railways Multan (BS-20), was appointed as Inquiry Officer, who provided sufficient opportunity to the above named officer to defend the charges leveled against him for submission of his defence but all proved fruitless. No formal reply to the charge sheet was received. Hence the inquiry officer submitted enquiry report, as per item 5 of charge sheet and the case was decided ex-parte. After consideration the inquiry report, he was issued Show Cause Notice on 22.04.2017. Since no reply was received, a Notice of unauthorized absence was published in Daily Newspapers on 28-07-2017, but he did not turn up.

2. The Competent Authority (Secretary/Chairperson Railways), after consideration of the above position and recommendation of Inquiry officer as well as authorized officer, has been pleased to impose a major penalty of **“Dismissal from Service”** upon **Mr. Mubashar Hassan Malik** under rule 5(iv) of Government Servants (Efficiency & Discipline) Rules, 1973.

3. Mr. Mubashar Hassan Malik, has right to prefer an appeal to the Prime Minister (appellate authority) against the above penalty within 30 days (Thirty Days) from the communication of this order.
