OBSERVANCE & IMPLEMENTATION OF 2% DISABILITY QUOTA.

The undersigned is directed to refer Establishment Division's O.M. No. 34/3/86-R-V dated 07.03.2023 on the above subject and to state that requisite information /data regarding present implementation status of the 2% disability quota of Pakistan Railways & Ministry of Railways has already been conveyed to Establishment Division vide this Ministry's OM of even number dated 01.02.2023 (Annex-I), wherein 213 seats against 2% disable quota have been calculated. Out of 213 seats, 93 seats are already filled while 121 posts are lying vacant.

- 2. Furthermore, it is apprised that Ministry of Railways presented its case No. 823/42/2020 in Cabinet regarding approval of the Restructuring and Revival Plan of Pakistan Railways on 27th October, 2020 through a summary to Cabinet Division. The Cabinet considered the summary titled " **Approval of the Restructuring and Revival Plan of Pakistan Railways**" and approved the restructuring and revival plan vide Cabinet Division's Memorandum No. 42/OM/2020-D dated 29.10.2020 (**Annex-II**) wherein item No. 10 of Financial Reforms (**Annex-III**) was approved and the same is reproduced below: -
- "There should be an immediate and complete freeze on all permanent employment in the organization. All new employment in Pakistan Railways should be on contract basis only."
- 3. It is pointed out that all the vacant seats against 2% disability quota are to be filled in, on regular basis.
- 4. In view of above, this Division is unable to implement 2% disability quota unless the ban is lifted by Federal Cabinet. This Ministry is already in a process to lift the ban imposed by Federal Cabinet (Annex-IV). As and when the Federal Cabinet grants the permission for employment on permanent basis the vacant posts against 2% disability quota will be filled as per instructions contained in para-2 of OM dated 19.01.2023 (Annex-V) in the light of the directives of Honourable Islamabad High Court, Islamabad.
