NOTIFICATION

No. 1(18)/Discipline/2024(P&D) The Prime Minister has perused the show cause notice issued by the Ministry of Railways, decision of the Authority, appeal of Mr. Ghulam Fareed, Ex-Ward Keeper/Mrn (BS-10), Pakistan Railways, General Store Mughalpura, Lahore and the hearing note submitted by the Hearing Officer in the instant case. After going through the complete record of the case, the Prime Minister, being the Appellate Authority, has concluded that the charges against the appellant in Show Cause Notice dated 20-08-2025 stood proved against him on account of theft of copper scrap material of 4270 kgs from Pakistan Railways General Store, Mughalpura, Lahore which leaves no grounds whatsoever to alter the decision of the Authority to impose major penalty of "Dismissal from Service" on the appellant.

In view thereof, the Prime Minister, in his capacity as Appellate Authority within the meaning of rule 2 of Civil Servants Appeal Rules, 1977, and in exercise of his powers, conferred under rule 6 of the Rules *ibid*, has been pleased to **reject** the appeal dated 20-11-2025, preferred by Mr. Ghulam Fareed, Ex-Ward Keeper/Mrn (BS-10), Pakistan Railways, General Store Mughalpura, Lahore against imposition of the major penalty of "Dismissal from Service".
