



NOTIFICATION

No. 1/(7)/Discipline/2022(P&D). Consequent upon finalization of disciplinary proceedings initiated under Civil Servants (Efficiency & Discipline) Rules, 2020 vide Show Cause Notice of even number dated 03.05.2023, the Secretary/ Chairman Railways, as Authority in terms of Rule 2(1)(c) of Civil Servants (Efficiency & Discipline) Rules 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to impose major penalty of "Removal from Service" upon Dr. Habiba Aman, Medical Officer (BS-18), Pakistan Railways Hassan Hospital, Karachi, in accordance with Rule 4 read with para (3) (d) of Civil Servants (Efficiency & Discipline) Rules, 2020 with immediate effect.

2. Dr. Habiba Aman has a right of appeal to the appellate authority against the above penalty under the Civil Servants (Appeal) Rules, 1977 within 30 days (thirty days) from the date of issuance of this Notification.
