

NOTIFICATION

No. 84/5/2025-Compensation. Consequent upon the judgment of Federal Service Tribunal (FST), Islamabad, dated 06.05.2025 passed in Appeal No. 1883(R)CS/2019 filed by Mr. Imran Afzal, a BS-17 officer of Civil Engineering Department of Pakistan Railways, ex-Assistant Executive Engineer (BS-17), Pakistan Railways, Larkana, presently working as Assistant Track Supply Officer (BS-17), Pakistan Railways, Lahore, and on the recommendations of the Department Committee constituted in terms of ESTACODE Rule Sl. No. 32.10(2), the competent authority (Secretary Railways) has been pleased to approve the intervening period from 20.06.2019 to 02.06.2025 treated **as duty** in the light of FR-54(a) in favor of Mr. Imran Afzal, subject to the final outcome of the CPLA.

2. The said period was decided subject to the condition that the officer will deposit/ return all the financial and other benefits which were given to him, if the decision of CPLA filed against the above mentioned FST decision, does not come in his favor.
