NOTIFICATION

No.1(14)/Discipline/2025(P&D). Consequent upon finalization of disciplinary proceedings initiated under Civil Servants (Efficiency & Discipline) Rules, 2020 vide order of inquiry of even number dated 17.10.2025, the Secretary/Chairman Railways, as Authority in terms of Rule 2(1)(c) of Civil Servants (Efficiency & Discipline) Rules 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to impose a minor penalty of “**Withholding of Increments for a period of one year without cumulative effect**” upon Mr. Muhammad Aamir Jillani, Head Clerk (BS-15), NDS/Lahore Division, in accordance with **Rule 4 (2) (b)** of the Civil Servants (Efficiency & Discipline) Rules 2020.

2. The official has the right of appeal to the Appellate Authority against the above penalty under the Civil Servants (Appeal) Rules, 1977 within 30 days (thirty days) from the date of issuance of this notification.


