NOTIFICATION

No.1(36)/Discipline/2024(P&D). Consequent upon finalization of disciplinary proceedings initiated under Civil Servants (Efficiency & Discipline) Rules, 2020 vide Show Cause Notice of even number dated 21.11.2024, the Secretary Railways, as Authority in terms of Rule 2(1)(c) of Civil Servants (Efficiency & Discipline) Rules 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to impose a major enalty of “Dismissal from Service” to Mr. Lal Nabi, ex. Assistant Works Manager/Furnishing (BS-17), Pakistan Railways, Carriage Factory, Islamabad in accordance with Rule 4 read with para 3(e) of Civil Servants (Efficiency & Discipline) Rules 2020.

Assistant Works Manager/Furnishing (BS-17), Pakistan Railways, Carriage Factory, Islamabad, has the right of appeal to the Appellate Authority against the above penalty under the Civil Servants (Appeal) Rules, 1977 within 30 days (thirty days) from the date of issuance of this Notification.


