No. 2(18)/Appeal/2023(P&D). The Prime Minister in his capacity as Appellate Authority after considering the record of the case as well as hearing note submitted by the Hearing Officer in the instant case has observed that the appellant failed to present any fresh and cogent evidence in his defence that require reconsideration of the orders of the Authority regarding imposition of major penalty of "Removal From Service".
