No. 1(11)/Discipline/2022(P&D). Consequent upon finalization of disciplinary proceedings initiated under civil servants (Efficiency and Discipline) Rules, 2020 vide order of inquiry and charge sheet of even number dated 19.12.2022, the Secretary/ Chairman Railways, as Authority in terms of rule 2(1)(c) of Civil Servants (Efficiency and Discipline) Rules 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to impose major penalty of **"Dismissal from Service"** upon Mr. Maqsood Ahmed, Inspector of Works/Ballast Inspector (BS-16), Pakistan Railways Sukkur in accordance with Rule 4 of sub rule (3) (e) of Civil Servants (Efficiency & Discipline) Rules, 2020.

2. The above mentioned official has the right of appeal to the appellate authority against the above penalty under the Civil Servants (Appeal) Rules, 1977 within 30 days (thirty days) from the date of issuance of this Notification.
