Consequent upon finalization of disciplinary proceedings initiated under Civil Servants (Efficiency & Discipline) Rules, 2020 vide Show Cause Notice of even number dated 23.09.2023, the Secretary/ Chairman Railways, as Authority in terms of Rule 2(1)(c) of Civil Servants (Efficiency & Discipline) Rules 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to impose major penalty of **"Reduction in time scale by 2 steps for 2 years"** upon Mr. Iqbal Ahmed, Deputy Chief Electrical Engineer/M (OPS/ BS-19), Pakistan Railways, Headquarters Office, Lahore, in accordance with Rule 4 of Sub Rule (3) (b) of Civil Servants (Efficiency & Discipline) Rules, 2020.

2. The above mentioned official has the right of appeal to the Appellate Authority against the above penalty under the Civil Servants (Appeal) Rules, 1977 within 30 days (thirty days) from the date of issuance of this Notification.
