In exercise of power vested under Rule 2(a)(1)(iii) of Civil Servants (Appeal) Rules, 1977, **The Honorable President of Pakistan/ Appellate Authority has rejected the appeal of Mr. Adnan Shafai, ex-BS-20 Officer of Pakistan Railways (Mechanical Engineering Department) (Appellant) against the imposition of major penalty of "Compulsory Retirement" along with "Recovery of embezzled money", as his appeal contains no cogent grounds for review of orders.**
