No.1 (12) Discipline/2024 (P&D). The Secretary Railways, as Authority in terms of Rule 2(1)(c) of Civil Servants (Efficiency & Discipline) Rules 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to impose a major penalty of “Dismissal from Service” upon Dr. Khalida Bano, Medical Officer (BS-17), Cairns Hospital, Pakistan Railways, Headquarters Office, Lahore, with immediate effect in terms of Rule 4 read with sub rule (3) clause (e) of the Rules ibid, as charge of unauthorized absence from duty was proved against her in disciplinary proceedings initiated vide Show Cause Notice dated 26.03.2024.
