No.15/1-3/2021/A-I(P&D) The Honorable President of Pakistan, being Appellate Authority, after observing all the facts of the case, in view of the seriousness of the charges, along with available record and documents submitted by the Appellant were examined, and in exercise of power vested under Rule 2(a)(1) (iii) of Civil Servants (Appeal) Rules, 1977 has **rejected** the appeal of **Mr. Ghulam Dastagir Khan Baloch, Ex. BS-20 officer of Railways (Comercial & Transportation) Group, Pakistan Railways (Appellant)** against the imposition of major penalty of “Dismissal from Service” as his appeal contains no cogent grounds for review of orders.
