**NOTIFICATION**

**No. 15-1-3-21-A-1-P&D:** In pursuance of judgment of the Federal Service Tribunal (FST), Islamabad dated 21.01.2026 passed in Appeal No. 235(L)2024 filed by Mr. Ghulam Dastagir Khan Baloch, a BS-20 officer of Railways Commercial & Transportation Group, the Prime Minister being authority under Rule 2(1)(c) of the Civil Servants (Efficiency & Discipline) Rules, 2020, has been pleased to set aside the major punishment of "Dismissal from Service" imposed upon the above-mentioned officer vide this Ministry's Notification No. 15/1-3/2021/A-I dated 15.12.2023 and to reinstate the officer into service **only for the purpose of providing him a chance of personal hearing by the authority** and thereafter the departmental proceedings be decided by the competent authority. The question of release of salary and back benefits shall be decided by the authority after conclusion of disciplinary proceedings.

2. The setting aside of major punishment of "Dismissal from Service" as stated above is subject to the final decision on merits by the Supreme Court.
