

**NOTIFICATION**

**No. 1(11)/Dis/2024(P&D).** The Prime Minister has seen and after going through the Charge Sheet, Inquiry Report, Show Cause Notice, decision of the Authority, and the note of Personal Hearing dated 12-07-2024, submitted by the Hearing Officer, has been pleased to observe that the appellant failed to present any fresh evidence in his defence that require **“Reduction to a lower post and pay scale from the substantive or regular post, for a period of three years”** without cumulative effect.

In view thereof, the Prime Minister, in his capacity as Appellate Authority within the meaning of Rule 2 of Civil Servants (Appeal) Rules, 1977 and in exercise of his powers conferred under Rule 6 of the Rules ibid, has been pleased to **reject** the appeal of Mr. Faisal Manzoor (BS-18), Ex-Dy. MCP /Stat, Pakistan Railways Headquarter Office Lahore, against imposition of major penalty of **“Reduction to a lower post and pay scale from the substantive or regular post, for a period of three years”**. The appeal of the officer is disposed of in above terms.
