NOTIFICATION

No.1(43)/Discipline/2024(P&D). Consequent upon finalization of disciplinary proceedings initiated under Civil Servants (Efficiency & Discipline) Rules, 2020 vide Show Cause Notice of even number dated 16.12.2024 against Mr. Fazal Mehmood, Ex-Private Secretary to DIG/ South (BS-18), Pakistan Railways Police, CPO, Lahore (presently working as Private Secretary to CPO, Pakistan Railways Police, Lahore & attached at Pakistan Railways Police, Mughalpura Division) in connection with gross misconduct and unbecoming of an officer for the act of omission or commission for anomaly in the figures reported to the Senate Standing Committee.

2. The accused officer was granted opportunity of personal hearing on 21.01.2025 at 14:30 hours at Ministry of Railways under Rule 7 (d) of Civil Servant (Efficiency & Discipline) Rules, 2020. He attended personal hearing as per schedule.

3. Upon a thorough review of the available records, the facts of the case, and fulfilling of all codal formalities, it is evident that although the accused officer has submitted incorrect facts and figures containing discrepancies, raising concerns about the accuracy and accountability. In the light of the officer's demonstrated commitment to accountability and assurance to avoid such lapses in the future, a lenient approach is being adopted. Accordingly, the accused officer is hereby "exonerated" from the charges under Rule 7(e) of the Civil Servant (Efficiency & Discipline) Rules, 2020, with a strict the officer is "warning" to be careful in future.
