NOTIFICATION

No. 15/8-3/2020-A.I (P&D). The Prime Minister in his capacity as Appellate Authority within the meaning of Rule 2 of Civil Servants (Appeal) Rules, 1977 and in exercise of his powers conferred under Rule 6 of the Rules ibid, has been pleased to accept the appeal of Mr. Fiaz Ahmed Khan, a BS-19 officer of Railways (Commercial & Transportation) Group, ex-Divisional Superintendent, Pakistan Railways, Peshawar, to the extent of setting aside the imposed penalty of "Compulsory Retirement from Service" vide its U.O. No. 2709/SPM/2023 dated 23.11.2023 hence the officer reinstated in service w.e.f. the date of imposition of penalty i.e. 28.09.2021 vide this Ministry's notification dated 28.11.2023. The Prime Minister further directed that a de-novo inquiry shall be conducted in the instant matter under Civil Servants (E&D) Rules, 2020.

2. The Secretary Railways (Authority) was initiated denovo disciplinary proceedings against Mr. Fiaz Ahmed Khan under Civil Servants (Efficiency & Discipline) Rules, 2020 and he was served with Charge Sheet with statement of allegations dated vide Order of Inquiry dated 28.11.2023 in connection with illegal allotment of land at Mardan. Mr. Adnan Rafiq, Member Finance (BS-21), Ministry of Railways, Islamabad, was nominated as denovo inquiry officer to conduct denovo inquiry against the accused officer, who vide his letter dated 23.10.2024 furnished the denovo inquiry report.

3. On the basis of denovo inquiry report, the accused officer was served Show Cause Notice dated 07.11.2024 under Rule 16(6) of Civil Servants (Efficiency & Discipline) Rules, 2020. The accused officer submitted its defence to the Show Cause Notice on 12.11.2024. The accused officer was granted opportunity of personal hearing on 22.11.2024 at Ministry of Railways under Rule 17 of Civil Servant (Efficiency & Discipline) Rules, 2020.

4. The Secretary Railways as Authority in terms of Rule 2(1)(c) of Civil Servants (Efficiency & Discipline) Rules, 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to "exonerate" Mr. Fiaz Ahmed Khan, from the charges leveled on him in accordance with Rule 16(5)&(7)(a) of Civil Servant (Efficiency & Discipline) Rules, 2020.
