NOTIFICATION

No.1(11)/Discipline/2022(P&D) The Prime Minister, being Appellate Authority, has seen the record of the cases as well as hearing note submitted by Hearing Officer in the instant case. Upon perusal of the record, the Prime Minister is of the opinion that decision of Authority i.e Secretary/Chairman Railways, of imposition of major penalty of "Dismissal from Service" upon Mr. Gul Hassan, Ex. AYM (BS-09), Pakistan Railways, Sukkur Division does not commensurate with the quantum of guilt and appears excessive.

2. In view thereof, the Prime Minister being Appellate Authority within the meaning of Rule 2 of Civil Servants (Appeal) Rules, 1977 and in exercise of his powers conferred under Rule 6 (2) of the Rules ibid, is pleased to modify the major penalty of "Dismissal from Service" imposed upon Mr. Gul Hassan, Ex. AYM (BS-09), Pakistan Railways, Sukkur Division, to minor penalty of "Withholding of increment for a period of three years" under Rule 4 (2) (b) of the Civil Servants (Efficiency and Discipline) Rules, 2020.
