NOTIFICATION

No.1(8)/Discipline/2024(P&D). Consequent upon finalization of disciplinary proceedings initiated under Civil Servants (Efficiency & Discipline) Rules, 2020 vide order of inquiry dated 20.02.2024, the Secretary/Chairman Railways, as Authority in terms of Rule 2(1)(c) of Civil Servants (Efficiency & Discipline) Rules 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to impose a minor penalty of **“Withholding of increment for a period of one year without cumulative effect”** upon Mr. Hameedullah Lashari, ex-Divisional Commercial Officer (BS-18), Pakistan Railways Sukkur Division now Senior Marketing Manager/Freight, Pakistan Railways, Headquarters Office, Lahore under Rule 4(2)(b) of the Civil Servants (Efficiency & Discipline) Rules, 2020. Furthermore, the officer is strictly warned to exercise greater care and diligence in the future.

Mr. Hameedullah Lashari, ex-Divisional Commercial Officer (BS-18), Pakistan Railways Sukkur Division now Senior Marketing Manager/Freight, Pakistan Railways, Headquarters Office, Lahore has the right of appeal to the Appellate Authority against the above penalty under the Civil Servants (Appeal) Rules, 1977 within 30 days (thirty days) from the date of issuance of this Notification.
