No. 15/7-1/2018/A-I (P&D) In light of judgment of the Federal Service Tribunal (FST), Islamabad dated 06.05.2025 passed in Appeal No.1883(R)CS/2019 filed by Mr. Imran Afzal, Ex. Assistant Executive Engineer (BS-17), Pakistan Railways Larkana, the competent authority (Secretary/Chairman Railways) has been pleased to **set aside** the punishment of "Removal from Service" imposed upon the aforesaid officer vide this Ministry's Notification dated 20.06.2018-Admn-I and to reinstate the officer into service from the date of removal i.e. 20.06.2019 subject to the final outcome of the CPLA, filed against the above mentioned judgement of FST. Furthermore, back benefits of his intervening period shall be decided in accordance with the procedure laid down in (SI.No. 32.10 of Estacode-2015, Page -868), and the law laid down by the Honorable Supreme Court of Pakistan reported as 2010 SCMR 11 titled "Federation of Pakistan through Secretary, Ministry of Education and other Vs. Naheed Naushahi".
