

**NOTIFICATION**

No. 1(37)/Discipline/2023(P&D). The Prime Minister, being Appellate Authority, has seen the record of the case as well as hearing note submitted by Hearing Officer in the instant case. Upon persusal of the record, the Prime Minister has observed that the appellant failed to present any fresh and cogent evidence in his defence that require reconsideration of the orders of the Authority regarding imposition of minor penalty of "Censure".
