NOTIFICATION

No. 1(26)/Discipline/2023(P&D). Consequent upon finalization of disciplinary proceedings initiated under Civil Servants (Efficiency & Discipline) Rules, 2020 vide show cause notice of even number dated 17.07.2023, the Secretary Railways, as Authority in terms of Rule 2(1)(c) of Civil Servants (Efficiency & Discipline) Rules 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to impose a major penalty of "Dismissal from Service" upon Mr. Khangar, Sister Incharge (BS-17), Pakistan Railways Hospital, Multan, in accordance with Rule 4 sub rule (3) clause (e) of Civil Servants (Efficiency & Discipline) Rules 2020.

2. Mr. Khangar, Sister Incharge (BS-17), Pakistan Railways Hospital, Multan, has the right of appeal to the Appellate Authority against the above penalty under the Civil Servants (Appeal) Rules, 1977 within 30 days (thirty days) from the date of issuance of this Notification.


