NOTIFICATION

No.1(8)/Discipline/2022-E-IV(P&D) The Prime Minister, being Appellate Authority, has seen the record of the case as well as hearing note submitted by Hearing Officer in the instant case. Upon perusal of the record, the Prime Minister has observed that the appellant failed to present any fresh and cogent evidence in his defence that require reconsideration of the orders of the Authority regarding imposition of minor penalty of **“Reduction to three lower stages in pay scale for three years without cumulative effect”**.

In view thereof, the Prime Minister being Appellate Authority within the meaning of Rule 2 of Civil Servants (Appeal) Rules, 1977 and in exercise of his powers conferred under Rule 6 of the Rules ibid, has been pleased to **reject the appeal** of Mr. Muhammad Khan, dated 15-01-2024 against imposition of minor penalty of **“Reduction to three lower stages in pay scale for three years without cumulative effect”**.
