NOTIFICATION

No.1(44)/Discipline/2024(P&D). Consequent upon finalization of disciplinary proceedings initiated under Civil Servants (Efficiency & Discipline) Rules, 2020 vide Show Cause Notice of even number dated 06.01.2025, the Secretary Railways, as Authority in terms of Rule 2(1)(c) of Civil Servants (Efficiency & Discipline) Rules 2020 read with Rule 6 of Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, has been pleased to impose a major penalty of "**Removal from Service**" upon Mr. Musharaf Majeed, Ex. AEN/NWS (**BS-17**), Pakistan Railways, Sukkur Division in accordance with Rule 4 read with para 3(d) of Civil Servants (Efficiency & Discipline) Rules 2020. Additionally, his absence period from 24.09.2024 is treated as "**leave without pay**".

2. Mr. Musharaf Majeed, Ex. AEN/NWS (**BS-17**), Pakistan Railways, Sukkur Division has the right of appeal to the Appellate Authority against the above penalty under the Civil Servants (Appeal) Rules, 1977 within 30 days (thirty days) from the date of issuance of this Notification.
