NOTIFICATION

No. 1(5)/Discipline/2024(P&D). The Prime Minister in his capacity as Appellate Authority within the meaning of Rule 2 (a)(1)(ii) of Civil Servants (Appeal) Rules, 1977 and in exercise of his powers conferred under Rule 6 of the Rules **ibid**, has set aside the major penalty of “**Dismissal from Service**” imposed upon Mr. Shaiq Zafar Sheikh, ex-Deputy Director-V (BS-18), Ministry of Railways, Islamabad and “**Reinstated**” the appellant in the service with immediate effect.

2. The Prime Minister has further directed that a “**De-Novo Inquiry**” shall be conducted against Mr. Shaiq Zafar Sheikh, ex-Deputy Director-V (BS-18), Ministry of Railways (Railway Board), Islamabad, on the same charges, under E&D Rules, 2020. The decision on the intervening period from Dismissal to re-instatement in the service shall be subject to outcome of the De-novo proceedings.
