NOTIFICATION

No.15(24-2/2021/A.I (P&D) The Prime Minister, being Appellate Authority, has seen the record of the cases as well as hearing note submitted by Hearing Officer in the instant case. Upon perusal of the record, the Prime Minister has observed that the appellant failed to present any fresh and cogent evidence in his defence that require reconsideration of the orders of the Authority regarding imposition of major penalty (**incorrectly mentioned as minor penalty**) of “**Reduction to lower 3 stages, pay scale for a period of 03 years without cumulative effect**”.

2. In view thereof, the Prime Minister in his capacity as Appellate Authority within the meaning of Rule 2 of Civil Servants (Appeal) Rules, 1977 and in exercise of his powers conferred under Rule 6 of the Rules ibid, has been pleased to reject the appeal of Mr. Wajdan Jawaid, against imposition of major penalty (**incorrectly mentioned as minor penalty**) of “**Reduction to lower 3 stages, pay scale for a period of 03 years without cumulative effect**”.
