

NOTIFICATION

No.15/10-3/2021 (P&D) The Prime Minister, being Appellate Authority and in exercise of powers within the meanings of Rule 2(1) (c) of Civil Servants (Efficiency & Discipline) Rules 2020, after perusal of the record of case, recommendations of the de-novo inquiry officer, Show Cause Notice, statements of the Appellant, Mr. Haroon Rahsid Mohmand, ex. Chief Terminal Manager/Dry, Ports, Pakistan Railways, Headquarter Office, Lahore acted as per authority vested to him being Chief Terminal Manager.

2. The Prime Minister has further been pleased to observe as per inquiry report submitted by Inquiry Officer, that the entire process of re-tendering and revision of technical evaluation criteria was repeatedly placed before the senior hierarchy who endorsed and approved the process and non from the senior hierarchy, at any state of process of re-tendering till award of contract, raised any objection. The Prime Minister has also been pleased to observe that to single out one officer for any deficiency in the whole process is difficult and unfair and no loss to exchequer was caused by the alleged misconduct, inefficiency and negligent working, rather the appellant contributed in making technical evaluation criterion more competitive and transparent as per findings of inquiry.

3. In view thereof, The Prime Minister, being Authority and in exercise of powers in terms of Rule 16 (7) (a) of Civil Servants (Efficiency & Discipline) Rules 2020, has been pleased to **agree with the recommendations** of the Inquiry Officer that charges leveled against him have not been proved and **exonerate** Mr. Haroon Rahsid Mohmand, (BS-20) ex. Chief Terminal Manager/Dry, Ports, Pakistan Railways, Headquarter Office, Lahore, from all allegations/charges leveled against him in the light of recommendations of the inquiry.
