

SHOW CAUSE NOTICE

Whereas, you, Mr. Jehangir Khan, Sister Incharge (BS-17), Pakistan Railways, Cairns Hospital/Lahore, are informed through this publication that you, were served with Show Cause Notice No. 1(11)Discipline/2025 (P&D) dated 05.06.2025 on account of your absence from duty w.e.f. 30.01.2025 which amounts to misconduct and renders you liable to be proceeded in terms of Rule 2 (k) of the Civil Servants (Efficiency & Discipline) Rules, 2020. Thus, you were required to submit your defense/ reply to the Show Cause in writing within 14 (fourteen) days from the date of receipt of it.
