



SHOW CAUSE NOTICE

Whereas, you, Mr. Faisal Adnan, Works Manager (Loco Rehabilitation) (BS-18), Pakistan Railways, Mughalpura, are informed through this publication that you, were served with Show Cause Notice No. 1(8)/Discipline/2024(P&D) dated 29.05.2025 on account of your absence from duty w.e.f. 22.03.2025 which amounts to misconduct and renders you liable to be proceeded in terms of Rule 2 (k) of the Civil Servants (Efficiency & Discipline) Rules, 2020. Thus, you were required to submit your defence/ reply to the Show Cause in writing within 14 (fourteen) days from the date of receipt of it. However, you did not respond to the aforesaid show cause notice.
