QUALIFICATIONS/CONDITIONS FOR APPOINTMENT BY TRANSFER

4. Appointment by transfer shall be made in accordance with the provisions of rule 7 and 9 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973.

PROBATION

5. Persons appointed by promotion or initial appointment or transfer shall be on probation for a period of one year. This period may be curtailed for good and sufficient reasons to be recorded or if considered necessary, it may be extended for a period, not exceeding one year as may be prescribed at the time of appointment. Appointment on probation shall be subject to the provisions of section 6 of Civil Servants Act, 1973, read with rule 21 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973.

6. This Notification issues with the concurrence of the Establishment Division's O.M. No. F. 21/3/92-R-3/R-6, dated 19th June, 2001 and supersedes this Ministry's Notification No. E-50-RR-1/2-11, dated 01-05-1952.
